Financial Report

As of Sunday, September 9, 2012,

The bank account balance is \$4911.45.

The report balance is \$3411.45. The operating fund decreased by \$1134 from the last report. The report balance is approximately \$4728 less than the same time last year.

In Joe M.'s stead, former district treasurer (and returning *star*) Michael D. presented the financial report. Contributions continue to be strong with an average of \$975 per month for the year. Contributions for August were \$894. Distribution checks to the GSO and Area were mailed but have not yet cleared.
