## **COMMITTEE REPORTS**

# DCM (Sam H.)

## Website (Jim H.)

- There was a crash of the website in early May.
- Need to decide if we want to renew the maintenance contract. Cost is \$700 per year. We already have the money set aside in 2013 budget.
- What does maintenance do? Our site is in wordpress with 15-20 add ons, which are constantly updating. Sometimes when you do the updates it breaks the site because the updates are not compatible with one another. The maintenance makes sure the updates get done, which are important for security.
- Rick S. would like to know how a GSR would know where to send the info for an event. It
  is not clear from the website how to put an event on the calendar. "Contact us" has
  mailing address but not email addresses. Jim thinks he can handle making a "contact us"
  button for calendar.
- Website hits are at about 160 a day and maintaining.

## 12 Concepts for World Service

Concept 7

General Service Board (GSB) is legal authority in AA, Conference Charter is not. How do we avoid being taken over by trustees and GSB? This model follows Tradition 2- trusted servant. Power balance is protected by traditions and other bylaws. The Conference theoretically only has an advisory role. One power they have is to reject the nominated trustees. The Conference can deny funds to the GSB. Trustees have no salaries. They have no financial interest. They can veto something that the Conference does.
