The Twelve Concepts of World Service Concept II- Ed M

"The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole society in its world affairs."

Background: 1955 Charter for General Service Conference created. Delegated the conference authority for maintenance of our World Services making the conference the voice and effective conscience of AA. While Concept 1 states that the final authority resides with the groups themselves, Concept 2 provides for how the voices of these groups will be expressed. GSRs meet at Area Assemblies and every two years elect a Delegate from among them. The Delegates meet with the Trustees of the General Service Board, the General Service Office and the Grapevine to deliberate all issues affecting AA. The Delegates have the authority to cast a vote representing their Area as well as the Power of Decision over any issues that may arise.

Old Business:

1) Quad-fold (see attachment) Rick S.

A motion was seconded and passed to print 1000 copies of the quadfold and make them available to groups in District 33.

2) Distribution of Excess District 33 Funds

\$3,096.14 left over from 2013. After much discussion, a motion was presented, seconded and passed (with substantial unanimity) to send \$1,000.00 to GSO, \$1,000.00 to Area 51, and to keep \$1,000.00 within District 33 to be used for 12th Step work, the exact nature of which will be decided at our March business meeting. After the minority was heard,

another vote was requested. The motion passed by a vote of 12 for the motion, 9 against.
