## The Twelve Concepts of World Service Concept III - Jon R

"As a traditional means of creating and maintaining a clearly defined working relation between the groups, the Conference, the A.A. General Service board and its several service corporations, staffs, committees, and executives, and of thus insuring their effective leadership, it is here suggested that we endow each of these elements of world service with a traditional "Right of Decision."

Our trusted servants can decide which problems they can dispose of themselves, and which problems must be brought back to the group for discussion. The group must realize that the fellowship must *trust their trusted servant*.

#### **Old Business:**

1) Last month it was decided to keep \$1000.00 of our excess funds in the District coffers to have on hand for 12 Step work. Proposals were entertained regarding the best way to utilize these funds. Proposals included disbursing the funds to Area and GSO, to sponsor new groups that may be in need of start-up funds and to add funds to the Unity Rally budget for this year.

A motion was made and seconded to use \$200.00 of the excess funds and add it to the \$300.00 already set aside for the Unity Rally. The motion was approved by a 13 to 2 vote. This will bring this year's Unity Rally budget up to \$500.00.

After discussion, a motion was made to contribute \$50.00 start up funding to a Hillsborough group, "Sisters In Sobriety," who had requested them. The remaining \$750.00 to be split evenly between Area 51 and GSO. The motion was seconded and approved by a 11 - 2 vote. The minority declined to comment after each vote.

2) It has been a tradition in our district to contribute \$75.00 to whatever district is hosting the Pre-Conference. A motion was presented to contribute the \$75.00 that we have budgeted for this purpose. The motion was unanimously approved.
